ISSUE: Final FFY 2026-2029 Transportation Improvement Program

REPORT AND VOTE: Consider approval of the Federal Fiscal Year 2026-2029 Transportation Improvement Program.

BACKGROUND:

The CIRTPA staff is annually required to develop a four-year Transportation Improvement Program (TIP) by updating the current TIP for the CIRTPA. The purpose of the TIP is to list all projects in the CIRTPA Planning Area which are using Federal funding and scheduled to begin within a designated period of the four federal fiscal years.

The CIRTPA staff requested that CIRTPA member governments and participating agencies review and report any project changes, new projects, or "roll-over" projects programmed in Federal Fiscal Year (FFY) 2025, 2026, 2027, 2028, and/or 2029. Staff generated a project list for the FFY 2026-2029 TIP using responses from each member government.

Staff submitted the FFY 2026-2029 TIP draft to the Iowa Department of Transportation (DOT) for review and comment on June 15, 2025. Staff incorporated comments received into the final draft. The final FFY 2026-2029 TIP is due to the Iowa DOT following approval.

CIRTPA staff scheduled a public input meeting for the FFY 2026-2029 TIP draft at 4:00 p.m. on Monday July 14, 2025 in person, in order to provide an opportunity for the public to comment. Zero comments were received by staff at that meeting or during the public input process.

A copy of the proposed final FFY 2026-2029 TIP will be provided prior to the meeting.

RECOMMENDATION:
